Class Schedule: Friday: Nursery 1 Pro-Novice 1, Nursery 2, Start Pro-Novice 2

Saturday: Pro-Novice 2 finish, Nursery 3, Open 1 Possibly start Open 2

Sunday: Open 2 Novice 1 Novice 2 plan to be finished at 5 pm

If time allows I will offer a 3rd Open run, entries will be taken at the trial.

Please Note: Any unnecessary chasing of the sheep will not be tolerated.

Start times or areas may be adjusted based on entries. Entry includes 2 tickets to Sheep & Wool festival. Payback only on 2 dogs per handler per class. No Entries accepted with out full payment.
